### **Catholic Social Teaching**



Our Home School Agreement support the development of the Catholic Social Teaching principle of Family and Community. Working together we build a stronger community.

#### Purpose and who was consulted?

This agreement encapsulates our belief that Parents, and carers (I have changed guardians for carers) are a child's first and most important educators. It is designed to help pupils reach the highest possible standards of achievement through close communication and effective partnership with Parents and Carers.

In drawing up this agreement parents and carers were surveyed to clarify their expectations of the school. Staff reviewed practices in communicating with parents/carers and pupils. Pupils were invited to comment on the extent to which pupil voice provides an effective vehicle for consulting them and involving them in decision-making.

Parents and Carers must acknowledge and support EPCHS's rules of all pupil's being Ready, Respectful, Safe and Kind.

Parents and Carers can be kept up to date with home school information via the Arbor portal or the Arbor App.

#### **Relationship to other policies**

This agreement relates most closely to the Home Learning, pupil discipline and registration policies and is relevant to other policies such as assessment, child protection, equality, teaching and learning. It impacts on the school's approach to the prospectus and the school profile.

#### Roles and responsibilities of the Headteacher, other staff, governors

The Headteacher will:

- ensure that the home-school agreement is reviewed annually in consultation with parents, pupils, staff and governors
- ensure that where parents do not read, English translations will be made available
- guide the governing body in their role during the consultation process.

#### The ECC Senior Leadership Team will:

- ensure Parents/Carers, pupils, staff and governors are consulted annually to proposed changes to the HSA
- ensure that a copy of the HSA is sent to every new entrant and that they are signed by parents/carers and pupils and returned to school
- arrange for non-returns to be followed up
- ensure reasons are recorded for those HSAs not signed and returned
- report to the relevant governor committee annually the number of agreements signed and reasons for those not signed and returned.

#### Parents/Carers, students, staff and governors will:

- be involved in reviewing the HSAs on an annual basis.
- Arrangements for monitoring, evaluation and review
- Monitoring of HSAs signed/not signed will take place annually by the Teaching and Learning Committee.
- The policy and the HSA will be reviewed annually.

### HOME SCHOOL AGREEMENT

In order to achieve all that is best for our pupils' education, upbringing and welfare, we as governors, parents/carers and pupils enter into the following agreement:

#### In working together, we will help pupils to:

- develop self-respect
- observe the Catholic way of life
- have concern for their Family, Community and School
- follow and show that they are Ready, Respectful, Safe and Kind by modelling responsibility, respectfulness and positive relationships, rights, resilience and a readiness to learn

#### As a school we will show this by:

- Promoting a culture of being Ready, Respectful, Safe and Kind
- modelling Responsibility, Respect and Relationships, Rights, Resilience and Readiness
- treating each pupil as a unique individual; in the eyes of God, by providing a full Catholic education and ensuring your child is valued
- creating a positive support environment for the pupils to work in;
  - by setting high standards for work and behaviour to ensure your child reaches their maximum potential
  - by building positive relationships by sharing common goals and expectations with each other
  - by being a welcoming place, providing a safe and secure environment where children can grow and develop
- providing a variety of opportunities for pupils to develop their individual talents

#### As a family you will:

- encourage your child to practice their faith and be respectful of the schools Catholic beliefs
- make sure your child attends school regularly and aim for 100% attendance reporting all absences on the day of absence.
- support the School Homework policy and Behaviour and Relationships policy
- attend school events and meetings where possible
- ensure your child wears full school uniform and conforms to the school policy on hairstyles
- ensure your child abides by the Internet and Mobile phone policies
- notify the school of any change of circumstances that may affect your child by ensuring that up-to-date information is on file
- encourage Ready, Respectful, Safe and Kind behaviour from your child/ren
